Meet the Member, Walt Honea, W4HM



Walter Honea, W4HM

When Walter Honea, W4HM, got his Amateur Radio license in Sept. 1936 fewer than half of all American households had a telephone.

Since that made dialing up his friends an impossibility, he wondered if there was a way to talk by radio. When he was in high school, Walter found an Amateur Radio handbook tucked away in the reference section of his hometown library in Kansas. Shortly thereafter in Sept. 1936 he became a licensed operator.

His new license came in handy less than two years later when a snowstorm hit his hometown, cutting off communications. He operated for nearly 24 hours, passing on mostly welfare messages for Western Union and even transcribing the news stories of the day for his local paper.

Walter also found his future career in the communications field and got a job for Braniff Airways in San Antonio working in communications. It was there he met his future wife, Letha. They later married and have since celebrated 64 years together.

After the Japanese bombed Pearl Harbor in 1941, the Army Air Corp expanded its San Antonio ground school and began looking for qualified people to teach the cadets communications and navigation. Walter took the job, which he held for the balance of the war.

Walter's next stop was Louisiana where he worked for the Federal Aviation Administration. He later moved to Texas where he worked in navigation communications. At that time, only large airports had radar, but that changed in 1956 when two airplanes collided over the Grand Canyon. The crash prompted the FAA purchase many more radar systems and Walter's job became traveling around the country installing them. He eventually landed in Fort Worth, Texas as a radar engineer and then later moved to Washington, D.C. where he lived for 12 years and worked in research and development. He spent his last six working years working out of Norfolk International Airport as a sector manager.

When one of his daughters moved to Washington, N.C., Walter and his wife decided to follow, building a house near hers and moving in Sept. 2004. Unfortunately, Walter fell in the garage last year and spent much of the year at the hospital recovering from injuries. In December, he and his wife moved into Cypress Glen in Greenville.

Walter is still working to get his station set up in his new home, but thanks to the help of club members, has gotten a 40 meter antenna put up and



That event is weather spotter training.

The Basic Spotter training took place February 18 in the Global Classroom on the first floor of the Science and Technology Building at East Carolina University. 13 BARC members and 2 non-ham's showed up for the training.

The training was conducted by John Cole of the National Weather Service in Newport. His presentation included many short videos, which greatly enhanced his training.

The role of amateur radio was stressed several times during the training. As it has been demonstrated many times in the past, amateur radio has the ability to pass information more quickly than other forms of communication.

The National Weather Service also knows that amateur radio operators are less likely to exaggerate what they may

be observing. They also recognized our dedication to emergency services.

I hope that those of you who made it to the Basic Spotter Training will make it out to the Advanced Spotter Training. For those who missed it, you are more than welcome to come to the Advanced Spotter Training. I found it worthwhile going to the training, even though I had been through it before. John Cole has a different program than the previous trainer did, which made it more interesting.

Even if you never use the training to call in any observations to the National Weather Service, having knowledge about how the weather works can help you protect yourself and your family when severe weather is threatening.

I would like to thank Eric Christensen, KF4OTN, for his efforts in bring this training to our area. He has also made arrangements to have the training taped and accessible to anyone on the Skywarn page of the Newport NWS website.



This month's Meet the Member is Walt, W4HM. He mentions a plane crash that caused the government to decide to install radars to cover the United States. It was the midair collision of a TWA Super Constellation and United Airline Douglas DC-7 over the Grand Canyon. There were 128 fatalities. As Walt states, it was the crash that caused Congress to appropriate funds for the CAA to start installation of approximately 100 Enroute Radars to cover the US. I ended up maintaining Air Route Surveillance Radar (ARSR) and associated equipment near Benson and Hickory,

NC for 29 years of my career. Congress also made the CAA an independent agency, the FAA. For those with Internet service, check out <http://www.doney.net/aroundaz/grandcanyoncrash.htm> for complete details of the crash and causes.

Another midair occurred on December 16, 1960 also between another TWA Super Constellation and a United Airlines aircraft, a Douglas DC-8 jetliner in a blinding snowstorm over Staten Island, New York. The TWA plane crashed on Staten Island and the DC-8 crashed in Brooklyn. There were 134 fatalities including 6 on the ground. This crash resulted in the installation of the ARTS-3 radar computer systems in large airports for traffic control. These systems are at the Raleigh-Durham and Charlotte airports. On July 19, 1967, a Piedmont Boeing 727 collided with a private Cessna 310 near Hendersonville, NC

about 8 miles South of the Asheville airport. There were 82 fatalities. This crash resulted in the installations of the ARTS-2 radar computer systems at small airports. These systems are now at four airports in North Carolina. I was involved with the ARTS-2 system in helping with development and teaching the course in 1976 and 1977 while at the FAA Academy in Oklahoma City.

Checking my radio log on the computer recently, I came up with some interesting contacts I made over the years in the Washington, DC area. First there was K3CG in 1958, the US Coast Guard Headquarters. The call has since been reissued. In 1993, it was the Capital Hill ARC, W3USS, and the Pentagon ARC, K4AF. In 2000, it was the National Press Club, W3AO, and the World Bank ARC, 4U1WB. Too bad Barry Goldwater, K7UGA, lost to LBJ in 1964. He said he would install a Mosley TA-33 on the White House. He sure would have had some pileups!- W4YDY

Ham Radio operators "True heroes," Rep Mike Ross, WD4DVR, says in "Salute"



US Rep Mike Ross, WD5DVR (D-AR), this week offered "A Salute to Ham Radio Operators" on the floor of the US House. Ross,

one of two Amateur Radio licensees in the House of Representatives (the other is Rep Greg Walden, W7EQI, R-OR), addressed his colleagues February 8 to recognize the contributions of the Amateur Radio community in the wake of last year's devastating hurricane season.

"Citizens throughout America

dedicated to this hobby--a hobby that some people consider old fashioned or obsolete--were true heroes in the aftermath of Hurricane Katrina as they were often the only line of communication available into the storm ravaged areas," Ross said.

He noted that while ham radio is often overlooked "in favor of flashier means of communication," Gulf Coast communities learned after the 2005 hurricanes that technology can be "highly vulnerable" to storm damage. "Ham radios, entirely self-contained transmitters, require no cell towers or satellites, simply a battery and a strip of wire as an antenna,"

Ross explained.

Because of the "critical intervention" of radio amateurs across the US, Ross said, many lives were saved following Hurricane Katrina.

"The dedication displayed by ham radio operators in the aftermath of Hurricane Katrina sets a tremendous example for us all," Ross concluded, noting that "now more than ever" he's proud to be an Amateur Radio operator. "The people whose lives were rescued as a result of the tireless dedication of ham radio operators will forever be grateful to these selfless public servants." - via *ARRL Letter Online* 2/10/06

Utility steps back from North Idaho BPL test deployment



Avista Utilities announced recently that it's re-evaluating its plans to deploy a broadband over power line (BPL) project in North Idaho. The company, which serves some 330,000 electrical power customers in three western states, said it and a BPL vendor had "mutually agreed" to end contract negotiations for a test deployment in

Post Falls. "We want to step back and look at how the industry is evolving in terms of technology and the business model," Avista Market Solutions Manager Dave Heyamoto said in a company news release February 9. While Avista did not name the BPL vendor, a February 3 article in Spokane, Washington's, *Spokesman-Review* newspaper identified the company as Communication Technologies (COMTek) of Chantilly, Vir-

ginia. COMTek operates the Manassas, Virginia, BPL rollout that's been the subject of Amateur Radio interference complaints. In mid-January, the ARRL again called on the FCC to order the Manassas BPL system shut down until it resolves the interference complaints. Avista says it has not set a timeline for any future BPL projects, which reportedly could involve power-grid monitoring. - via *ARRL Letter Online* 2/17/06

FCC noncommittal on "Morse Code" proceeding action

Just when the FCC will act on the "Morse code" proceeding, WT Docket 05-235, remains hazy. The Commission released a Notice of Proposed Rule Making and Order (NPRM&O) last July proposing to eliminate the Element 1 (5 WPM) Morse code requirement for all license classes. The Amateur Radio community has filed more than 3800 comments on the proceeding, and additional comments continue to show up, even though the formal comment deadline was last October 31 (with reply comments by November 14). The next--and most-anticipated--step for the Commission is to formally adopt any revisions to its rules and conclude the proceeding with a Report and Order (R&O) that spells out the changes and specifies their effective date.

"There really is no news," an FCC Wireless Telecommunications Bureau staffer told ARRL this week on background. "We certainly hope to release WT Docket 05-235 sometime this year, but we're not making any predictions at this time. We certainly are not saving up any big announcements for Dayton Hamvention."

Beyond eliminating the Morse

requirement, the FCC declined proposing any other suggested changes to the Amateur Service.

The proceeding began with 18 petitions for rule making--many just calling for the elimination of the Morse requirement but some asking for more far-reaching changes in the Amateur Service rules. The various petitions attracted a total of some 6200 comments. The FCC subsequently consolidated the petitions--including one from the ARRL asking the FCC to establish a new entry-level license class and to retain the Morse requirement only for Amateur Extra class applicants--into a single proceeding designated WT 05-235.

The FCC has not proposed extending HF privileges to current Technician licensees who have not passed a Morse code examination. In its NPRM&O the FCC suggested that in a no-Morse requirement regime, "codeless Techs" could gain HF access by taking the Element 3 General class written examination.

Any FCC decision to eliminate the 5 WPM Morse code requirement for HF access would have *no* impact on either the current HF CW-only subbands or

on the CW privileges of Amateur Radio licensees.

Before it releases an R&O on the Morse code proceeding, however, the WTB wants to wrap up action in another Amateur Radio-related docket--the "Phone Band Expansion" (or "Omnibus") NPRM in WT Docket 04-140, released April 15, 2004. A dozen petitions for rulemaking, some dating back to 2001, were consolidated in the Omnibus proceeding.

In that NPRM, the Commission proposed to go along with the ARRL's Novice refarming plan aimed at reallocating the current Novice/Tech Plus subbands and expanding portions of the 80, 40 and 15 meter phone bands. The FCC also agreed with an ARRL proposal to extend privileges in the current General CW-only HF subbands to present Novice and Tech Plus licensees (or Technicians with Element 1 credit). WT 04-140 further proposed to essentially do away with FCC rules prohibiting the manufacture and marketing to Amateur Radio operators of amplifiers capable of operation on 12 and 10 meters. - *Via ARRL Letter Online 2/17/06*

Injured miner, Randy McCloy, KC8VKZ, talking, joking

Randy McCloy, KC8VKZ--the lone survivor of the January 2 Sago Mine disaster in Upshur County, West Virginia--is continuing to recover. Speaking on The Early Show on CBS TV March 2, McCloy's wife Anna told co-anchor Hannah Storm that her husband is talking again and even telling jokes.

"He'll listen to jokes and understand," Anna McCloy told Storm. "He'll talk to me and the kids--just regular conversation."

She also said McCloy has told her he remembers "bits and pieces" of the mining disaster that left 12 of his co-workers dead of carbon monoxide poisoning. McCloy, 26, who's been in a rehabilitation facility since January 26, also answers questions appropriately, recognizes his family and can "move quite well," Anna McCloy said. Revised, corrected Element 2 question pool released

The Question Pool Committee (QPC) of the National Conference of Volunteer Examiner Coordinators (NCVEC) has announced the release of a revised and corrected Element 2 (Technician) question pool. The new Element 2 question pool becomes effective for all Technician-class Amateur Radio examinations administered on or after July 1, 2006. Changes from the initial Element 2 question pool include elimination of some questions (T5D06, T6B09 and T7A08) and rewording of others to increase clarity. "We thank those users who reported the errors and made other suggestions for ways to improve the product," the committee said. "The QPC reviewed all submissions and incorporated the changes that were appropriate." The QPC warned that only the Element 2 question pool dated February 6, 2006, is valid. The new Element 2 database is available for download from the NCVEC Web site as a PDF, MS-Word, Rich Text Format (RTF) or ASCII text file <http://www.ncvec.org/ama_news_article.php?id=82>.
